- 2. I have read the facts set out in Part 2: Factual Basis of the Notice of Application of myself and 1083163 Alberta Ltd. dated February 20, 2020. To the best of my knowledge and belief, the facts set out therein are true.
- Attached hereto as Exhibits "A", "B", "C" and "D" are copies of invoices from McMillan LLP to me and 1083163 Alberta Ltd. ("1083163") dated August 12, 2019 and December 31, 2019. 1083163 and I jointly retained McMillan LLP to represent us in this matter. As I was owed approximately twice as much as 1083163 by the Petitioner, we agreed that I would pay two-thirds of McMillan's charges and 1083163 would pay one-third. All of these invoices have been paid.


